General Report Comments: On arrival at this property the owner Mr Clayton Cupido was at work in Vredenburg . I spoke with his son Jayden. There is two dogs on this property. One is a male Pitbul named Face and the other is a juvenile female Pitbul X named Mercy.

Face:
Face is on a short static chain of about a meter and half to two meters long with a collar around his neck. Face is emaciated and his body condition is unacceptable. I observed fresh drinking water and shelter meant for Face. The living environment around Face's kennel is clean.

Mercy:
Mercy is a brown,white + black juvenile female Pitbul X. She is on a long static chain joined with a rope. Her body condition is fair and acceptable.I observed fresh drinking water,shelter and a collar around her neck. The living environment around Mercy's kennel is clean.

Overral:
There is no food available for the dogs so I issued a warning advising Mr Clayton Cupido to:
(1) seek vet assessment regarding the dog named Face's body condition
(2) provide adequate dog food for Face
(3) remove the dog named Face from the short chain.

After I was done with the inspection I gave Mr Clayton a call advising him that I was on my way to his work place in Vredenburg. I met Mr Clayton at his work place and I explained every detail of the warning which I issued. He signed the warning and then decided to surrender the dog named Face.
