General Report Comments: There is three dogs on this property and all three dogs are on short chains. The following is welfare inspection dog by dog.

Seun:
Seun is a black + tan male terrier X dog. He is not neutered. Seun is on a short static chain with a collar around his neck. Seun does not have adequate shelter as his kennel is broken on one side. Seun's body condition is fair and acceptable. The living environment is clean. I observed fresh drinking water next to Seun's kennel.

Lady:
Lady is a brown and white female worshond. She is on a short static chsin without a collar. Lady has what looks like cancer on her stomarch. She is not sterilized. I observed water and shelter .

Coffee:
Coffee is a white + black unsterilized Huskey male dog. He too is on a short static chain with a collar around his neck. Coffee has a big growth on his right back leg which looks like cancer . Coffee does have shelter and I observed fresh drinking water for him.

There were some walfare concern that I observed and I issued a warning for the following walfare concern and after I issued the 24hour warning for Vet treatment and cleaning the area around Lady's kennel Antonette decided to surrender the dogs named Coffee and Lady .

(1)clean the area around Lady's kennel
(2)provide adequate shelter for Seun
(3)provide vet treatment for what looks like cancer on the dogs named Lady and Coffee
(4)remove all three dogs from the short chains..

I am no longer going to recheck in 24hours as the issues which I issued a warning for are now invalid because the dogs were surrendered.
