General Report Comments: On my arrival, I was welcomed by Mrs Lena Nero, I introduced myself and explained my visit to the property, I then observed the following animals: 1) white pitbul male of +-2 years of aged named Bullet, 2) a male tabby+white adult cat named Spiker, 3) a male chihuahua brown dog of +-4 years named Vagter.

Only Bullet was on a static light chain of 4 meters long, and Bullet appeared physically not looking good in skin condition (possibly mange) and was busy biting itself around the infected skin. Shelter was available, water was available and living environment was cleaned.

Spiker and Vagter all appeared physically looking good in condition with no veterinary problems or health concerns. They live inside the house.

Mrs Lena said she was waiting for the spca as the complainant did I from them that she is going to call the spca on behalf of Bullet, Mrs Lena then surrendered Bullet because she can't afford adequate veterinary treatment.

I then collected the dog Bullet and brought it to the spca Darling and was humanely euthanized, see admission no E3587.

I then educated Mrs Lena that in future should she come across the same or similar situations regarding animals, she must contact the spca on 0224922781 or Alternatively speak to the complainant to contact the spca on her behalf since they know each other.
