Johannes works for GA civils and he who also stays on the premises with his family and three dogs. We went to see the dogs where they were in a big enclosure with enough space for them to move around and also to protect them from the weather elements. Water was observed. The enclosure was dirty with dog feaces lying around. There are 2x female adult dogs and 1x adult male. All the dogs are sterilized and their body condition is acceptable. Johannes told me that he can't let them out during the day because the gate is open the whole day and there is a lot of trucks coming in an out from the premises. I issued warning W6283 to clean the dogs living area. Will follow up.
