General Report Comments: On my arrival, I hooted and shouted but did not get any response, it looked like there was no one available in the property. The property was secured with precast type fence of approximately 6-7 meters high and with a see through steel palisade sliding gate of also approximately 6-7 meters high.

While I was standing at the gate , I observed through the gate the 2 dogs came to the gate(brown female Africanis breed, and black+brown German shepherd cross breed), both dogs appeared physically not looking good in body scoring 2/5 and body condition(underweight). Shelter(dog kennel) big enough was available, living environment was cleaned, and there was a silver bowl and red bowl close to the dog kennel of which I couldn't be able to see if there is water in them.

I then went to the neighbors house no 18 corner Jasmyn street and Denne Ave, there I was welcomed by Mr Algurnand Daniels, I introduced myself and explained my visit to his property, I then kindly asked him if he do know the owners of house no 20 Jasmyn Street as his neighbors, and I aslo asked him if I can gain access into his property to view at the back of house no 20 Jasmyn Street property(I then observed from the back of the house no 20 and I couldn't see any animals at the back).

I then issued a notice to comply to the owners to:

- 1) provide the animal/s with sufficient potable water.....,
- 2) provide the animal/s with adequate food on a daily.....,
- 3) provide the animal/s with comfortable bedding. Refer to attached notice to comply no I005901.

I then gave the notice to comply to Mr Algurnand Daniels of which he did accepted the notice to hand it over to the owners in house no 20 Jasmyn Street WESBANK Malmesbury.
