I asked Sibongile what happened to the dog and said the dog was loose and fought with other dogs and the are boys that pass walk with their dogs and they start fighting. I asked her to surrender the dog to SPCA so that the dog can get treatment. She and some community refused with other two boys who claimed the dog belong to all of them. One of the boy unchain the dog and said he is taking it away another property since I want to take his dog away. I told the community that I'm not here to take your dog for no reason I'm worried about the welfare issues of the dog:- clenannesss, type of food, not adequate shelter, injury of the dog. The complainant back me up and brushed the dog told them they should listen to me and listen is a skill. I educated them told them they must fix the concerns I've raised failure to obey then I'll be forced to remove the dog and legal action will be taken against them.

They seem to understand and I was told they will comply with what I've told them and bring the dog to the Sandton SPCA to be checked by the vet and be sterilize , vaccinated.

I asked Tlale to keep an eye for me on the dog privately and she agreed .
