General Report Comments: Arrived at the property, I met a gentleman who was seemingly busy cleaning who identified himself as a Mzwandile Zwane. I asked Mr Zwane whether this was a correct address and he confirmed it. He also confirmed owning the dogs including the Pitbull in question and he said got the dog on a chain. I asked him to show me where he keeps the dog and he showed me the dog and the rest of them. He owns 4 greyhounds and a cross Pitbull. The greyhounds were roaming freely in the yard in exception of the Pitbull which was on a chain fixed to a washing line post. Water and an asbestos kennel were provided next to the dog. He said I found him while cleaning the yard for dogs as he works night shift and he was resting for the morning and just woke when I caught him. He told me he keeps the dog on chain because the dog is aggressive and can be uncontrollable especially when he is not home for work. I explained to him the dangers of owning a dog of such temperament can get him in trouble with the community regarding their safety and still be liable for animal cruelty implications with the law given his living situation. The yard is not properly fenced, the gate remains open for all as there were fellow tenants of his on the property. I persuaded him to surrender the dog to the Sandton SPCA but he told me he still needed to inform someone in the family and I must just come tomorrow to fetch the dog. I arranged with him to fetch the dog the next day and still issued him with a written warning for issues I noted. To come and fetch the dog tomorrow.
