General Report Comments: No one was available at this property and the common belief is that they moved 3 months ago. The property formerly operated a primary school called Greenfield Primary School. There was a Jack Russell-type puppy that kept escaping in and out the yard seemingly very skittish of strangers. No sign of the basic necessities(shelter, water and food bowls) provided for the puppy when checking from the gate. The puppy appeared to be in average body condition score. I tried phoning the school's contacts to no avail. Because there was no apparent feeding station visible from the gate, I left a 2 in 1 green plastic feeding bowl of food and water in case the dog was just a stray hiding at this house for safety. The complainant later noticed me driving on their way back from work and stopped to offer me some help. I told them that due procedure still needs to be adhered to even though it may be a longer process. I left a warning note for the owner to contact me within 24 hours urgently and attached the note at the gate. To follow up tomorrow
