General Report Comments: I met the owner upon arrival at the address in question, Mr Kabelo Sekgwela who was found keeping an 8-month-old, tan, white spots and black, muzzle, (intact)male dog, in a dark, dirty, passage-way-sized enclosure and used a wooden board to lock the dog inside. There were damaged couches being stored in this passage provided for the dog as a resting place. Feeding containers were empty and the place was dirty and unhygienic to keep a dog there. Kabelo immediately freed the dog from being confined explaining to us that the neighbours have been complaining about the dog pooping their space that is why he had to lock the dog up. The dog also appeared to be slightly underfed and according to Kabelo "Grisley" gets fed whatever they eat in the house. We tried to persuade the owner to surrender the dog to us but informed us of an alternative place in Kempton Park after we also spoke to his grandmother who phoned her other daughter, Kabelo's aunt during our inspection. We issued him with a 24-hour written warning to find the dog an alternative place or he will be forced to surrender the dog tomorrow.
