General Report Comments: The exact house was confirmed and upon arriving, the house is situated on a narrow lane (about a driveway size) or in a concealed driveway. I couldn't gain access from the main gate as the Lane leads to the school property. I then proceeded to the school to request access to the house in question. The security guard, Mr Lovemore Dube granted me entry to get to the house. I asked multiple residents in the area for the owner/occupant's contact details but no one appeared to have them. The owner of the dog is said to be renting the house but moved out over 3 weeks ago. The gate at the house was not locked and I pushed it open where I found the house vacated and the dog left without reportedly making any appropriate arrangements by the owner for the dog. There was a large green igloo dog kennel barricaded with wooden boards in one corner that consisted of an outdoor toilet-shower room and the place was very dirty with faecal waste and untidy. There were signs of dog food(pellets) being pushed under the gate to feed the dog and allegedly by the complainant and some of the neighbours in the area. I also found an empty bowl of food but a bucket filled with water left in the veranda. Multiple credible witnesses stated that the owners had moved out over 3 weeks ago without a trace. The house was not locked and no longer furnished when I inspected the whole house to ensure that there were no other animals kept in the house. I then impounded the dog based on these circumstances to prevent any further unnecessary suffering likely to happen because of owner's action of possibly abandoning the dog whether temporary or otherwise and I issued a Seizure Notice (with our contact number) and reported the Seizure at the Cleveland Police Station. OB. No. 2205/10/2024 20 The dog will remain in our custody until any new development in the next 7 days.
