General Report Comments: We met the organisers on arrival, Mr Duncan and the team, one of whom was their legal advisor. Along with the Norwood SAPS, we served them with a warrant explaining how we would be conducting our inspection and intervening wherever necessary. Inspector Denise Govender first confronted a person of interest from the previous show from Joker Bullies who provided her with misleading details/information. He was then issued a written warning for his actions.

We proceeded to inspect all the animals at the show. An estimated 17 American Bully breeder/Kennel projects were found at the Bully Show. Approximately 60 dogs (Bullies) were inspected while competing in their respective categories. The holding area consisted of gazebos under which Bully breeders were holding dogs in transporting cages/crates together as friends or kennel projects. The weather was overcast and most dogs appeared to be settled and were finding the weather conditions optimum. Various Bully breeders had already been issued with warnings by Inspector Govender at other previous shows, but we came across new breeders. Of all the total dogs inspected, at least 38 dogs had cropped ears, but none of them appeared to be freshly done. The dogs belonged to at least 14 breeders/kennel projects. All 14 breeders/kennel projects were issued a written warning for future purposes/foreseeability. At least 3 breeders were previously issued with warnings by Inspector Govender at other various Bully shows. We just had no trace of one of the owners of 3 American Bullies under the United Bullies' gazebo.

A few breeders were educated about the ear-cropping being viewed as an offence in respect of animals. We still stood against the idea of cropping and docking animal body parts despite their justification. Bully shows Inspections to be carried out as and when organised or through public info.
