| Comments:       | <p>I found Ms Sindisiwe Nyoni at the house, who showed me the injured dog on their veranda. The dog appeared to be wet, disorientated and traumatized. I tried interacting with the dog to have an idea of the severity of the injuries but the dog was still in a traumatic and non-responsive state. It was a 12-year-old, tan, neutered male, crossbreed (Africanis large type) dog named "Simba". Ms Nyoni also appeared to be shocked by what she had just experienced. Upon a serious discussion with her, I indicated the severity of Simba's injuries - head and jugular trauma, from the fight and reiterated to her that we won't be able to treat his injuries, euthanasia would only be the solution to end suffering the same way my colleague explained to her over the phone. I gave her the option to either help her get the dog into her car to take Simba to the vet or surrender the dog. She had doubts at first, knowing that Simba was going to be put down. I then spoke to her mother was not around over the phone, and she was reasonable enough to agree to what I was telling her. The other dog was not showing signs of being injured. Ms Sindisiwe signed over for the Request for Euthanasia the dog while Simba was gently loaded in the vehicle, and Simba was later euthanized.
