I asked him about the incident and he said it happened in their common driveway when they had a gardener over working in the yard who left the separating gates open which led to the 2 male dogs finding a way to run into the driveway and attacked the child because she started screaming and all Mr Mafisa could hear was the screaming from the driveway while he was in his room and he quickly rushed to find out only to find the incident happened. He said he tried helping in the best way he could and gave his statement to the police. I offered him to surrender the dogs to the SPCA as an option to avoid harsher penalties if found guilty . No offenses in respect of animals found on the property.
