General Report Comments: When I got to the gate, the owner's wife was driving down the driveway to the gate. I spoke to her to find out if she received my Warning, and she stated that she had, but her husband was still away and coming back on the 18th of April. She said she would rather have me deal with her husband, but I insisted on checking up on the dogs. She made claims that they were feeling harassed. Although she was upset, I managed to convince her to take me inside, where I found the 2 dogs placed in a carport-sized enclosure. The enclosure was spacious and arguably provided unobstructed movement for both dogs. There was a bucket of potable water and a resting place for them in the enclosure. Keletso said that the dogs are being enclosed because of having multiple tenants and workers on the property. I previously suggested partitioning the yard in a manner that would accommodate everyone but he said they had budget constraints for such a big renovation, but I told him to consider it. The dogs have a routine of being placed in the enclosure during the day and being freed at night, according to Keletso. An immediate neighbour vouched for them, saying that they would normally see the dogs running in the yard at night but never see them during the day, as my way to verify these claims from an objective party/witness. From what I can gather, the dogs are not enclosed in a manner or position that would cause them unnecessary suffering. The young dog was no longer placed in the small metal cage. No offenses in respect of animals that compel an action taken against the owner. To ask the complainant to remain our eyes and ears on the matter
