General Report Comments: The address being was discovered to be at or near 4c Osbourn Road, Fellside. It was an informal outlet operating in live chicken (poultry) and egg sale called B's Live Chicken and Eggs to members of public. I found 47 live chickens in white snack display racks stacked together. The chickens were held in groups of a maximum of 4 chickens in the cages. The shopkeeper who was a Malawian national did have any ID on him and could not communicate well in English. The chickens had dirty containers for feeding that appeared to be contaminated with faeces and were still being fed from. No compliance of registration with relevant regulatory body, health and safety protocols regulated in their field of business. Although, water was available in all cages there were a few droppings of faeces in chicken drinkers and feeding containers. I insisted to also look into their methods of slaughtering (knives and bleeders, poultry processing equipment) which was not acceptable by law. The slaughter knife was blunt and they used a kitchen drain gley as the bleeding pit. I issued a written warning for these issues found to be rectified within 10 days. To visit the outlet again in 10 days.
