General Report Comments: The doors were closed upon my arrival, but I could count at least 8 chickens still kept in cages when I looked through the window of the shop. No one was at the shop both in front and at the back. The room temperature appeared to have a high percentage of humidity due to lack of ventilation. I contacted the owner, Mr OJ Emanuels, who claimed that he had closed the business/operation because of all these complaints. He stated that the chickens I saw were held for private consumption and not for sale to public. I told him that he must make a reasonable time for us to do a proper inspection as he was telling me he only arrives home at 6 pm and he is the one only with the keys. Mr Emanuels asked for an extension until the end of the week, but I told him that he can't leave the chickens unattended and he should make the situation better for the chickens within 24 hours. I informed him I will be leaving him a warning on the shop gate because he couldn't speak to openly while he was at work. To follow-up on the chickens.
