Do hereby make oath and state that:

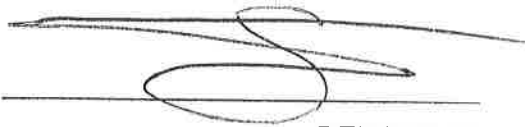

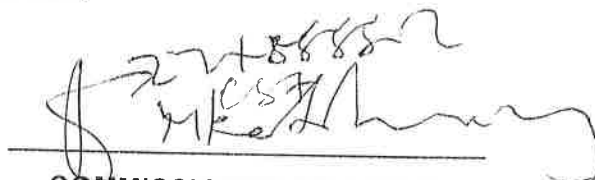

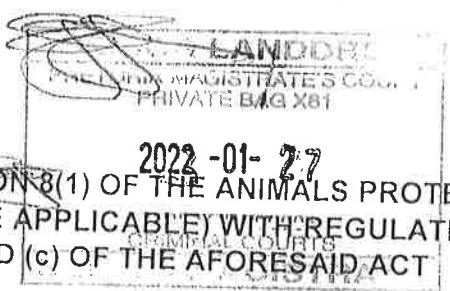

WARRANT IN TERMS OF SECTION 8(1) OF THE ANIMALS PROTECTION ACT 71 OF 1962, READ TOGETHER (WHERE APPLICABLE) WITH REGULATION 468 ISSUED IN TERMS OF SECTION 10(1)(b) AND (c) OF THE AFORESAID ACT

To: **SPCA TSHWANE (CENTURION)**
(INSPECTOR) SERRA GOURIET

WHEREAS it appears to me from the information provided on oath that there are reasonable grounds to believe that within the Magisterial District of **TSHWANE** there is/are certain **ANIMALS** in the possession of/ under the control of/ upon the premises of and/or upon the person **UNKNOWN (OWNER/OCCUPIER)** of **LOT PLOT 117 5TH AVENUE, GERHARDSVILLE, CENTURION** of whose conditions are required to be examined for the purposes of determining whether an offence in terms of section 2 of the aforesaid Act has been, is being or is likely to be committed.

This is therefore to authorise you to enter and search the identified premises and direct you to:

1. Examine the animal/s and the conditions in which it/they is/ are kept.
2. Take such photographs and/or video footage of such conditions as may be reasonably necessary.
3. Take into custody any and all evidence and/or equipment required for the purposes of a prosecution.
4. Search all buildings and vehicles on the property.
5. If necessary, take with you onto the aforesaid property the following persons:

6. Seize any animal/s and take it/them into your custody if it reasonably necessary to prevent cruelty to or suffering of such animal/s
7. Deal with it/them according to law or bring it/them before me to be dealt with the according to law.
