Report/Findings:

The pitbull male intact dog was found in the property being kept on a chain. The dog's bodily condition was found to be acceptable as per visual assessment however it had an open growth possible TVT. The owner was not at home at the time of inspection and the dog was surrendered by the member of the family. Because the dog did not receive medical or veterinary attention and the shelter was not adequate the warning was then issued to the rightful owner being the father of the complainant. The dog was then put down by the veterinarian and there are no other dogs at the property.
