Upon inspection, a sum of 4 adult pitbulls including 6 puppies were observed roaming the property. They appeared to be in good condition with two adult Pitbulls observed with visible bite marks. The two were surrendered to the SPCA as advised and as it stated that they are both fighting constantly. The dogs were sheltered, fed and watered appropriately. Owner advised on animal welfare and intends to sterilize the remaining male in future.
