You are hereby warned:

An inspection was conducted at your property as per complaint regarding the dogs belonging to yourself. Upon inspection, the following welfare concerns were observed:

1. 7 dogs were noticed in your property of which 6 were kept on heavy chains.
 - You are being informed that chained dogs typically become aggressive and or fearful. When they escape the chains they are likely to bite or attack anyone or everyone including their owners. Children are the most common victims. Keeping dogs in a condition noticed in your property makes them unstable, dangerous and not protective.
 - If your dogs should be restrained, you are requested to place them on a running wire with a minimum of 5m long with a 2m light chain to the collar. All dogs must then have easy access to shelter, food and water.

You are requested adhere to the above within the next 7 days.

2. Part of the environment where the dogs are placed was not up-kept.
 - The area where the dogs are kept must always be cleaned and kept in an acceptable hygienic condition.

You are requested to have the environment cleaned within 48 hours and keep it as such.

This warning has been issued in terms of the Society for the Prevention of Cruelty to Animals Act No 169 of 1993.

Failure to comply with this warning may render you liable for prosecution under the Animals Protection act No 71 of 1962 and / or Performing Animals Protection Act No 24 of 1935.

Any Person who – Obstructs hinders or resists an officer in terms of the Animals Protection act No 71 of 1962 or conceals any animal shall be guilty of an offence in terms of Section 8 (4) of the aforementioned Act.
