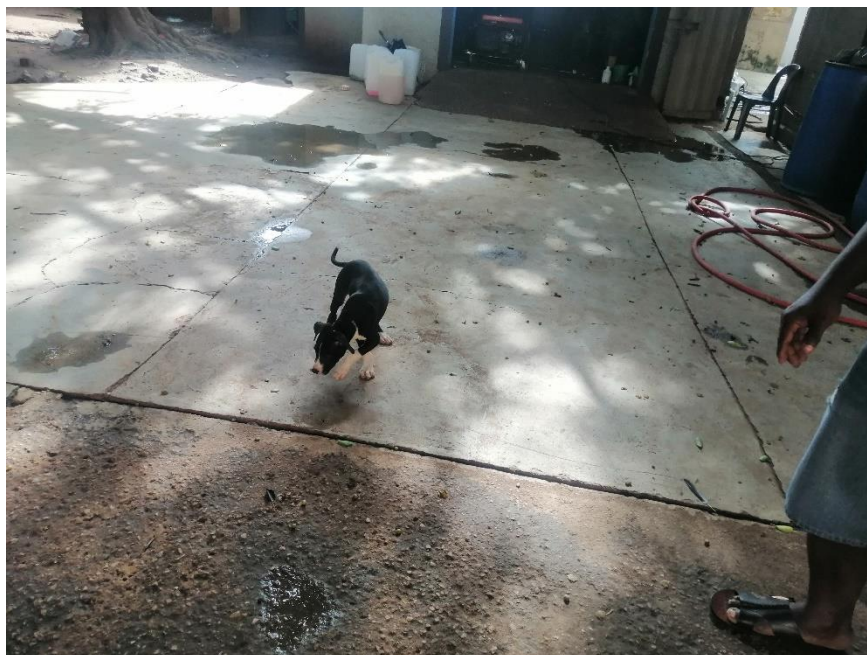


Fig 1.1 shows the dog found at the premise, the dog was playing and roaming free in the yard on arrival.
