None of them looked sick or injured.  
They hatch twice a week, Sunday and Wednesday.  
When asked how they dispose of unhatched eggs and deformed chicks, he told us they gas the chicks and feed the unhatched eggs to the Pigs. They have 4 sheds but only make use of 2. The only bio-security seen was a walk-through foot bath. We told him we would come back as we wanted to monitor the whole process. He said must come back when his boss is there.  
The owner of the property was not there.  
On Wednesday I called the owner, and he said he was coming back on Thursday 1 February. We will go back next week on Thursday, but he keeps delaying us we will get a warrant to go back.
