General Report Comments: I was with Field officer King on this Case

Upon arrival we met Mohamed who is the owner of the property. I shared a nature of complain and he granted us access to enter the property. He claimed he knows who the complainant is and i told him it was an anonymous complain.

I observed two dogs on property. The dog named Alpha appears to be in a good condition and clinically alert. The dog named Zena was observed roaming freely and the dog appears to have a matted coat. Both dog's are roaming freely on property and the have access to portable water. The dogs can walk around the property but Mohamed is a Panelbeater it seems he is working on the property to run his business. About 20 cars are on his property and there are no feaces seen on site. The dogs have access to adequate shelter that is placed under the plants for shade.

I then questioned him why he has so many cars but he then told me the property will be cleared next week as he found a place to rent for storage of his vehicles. Mohamed then told me that Zena doesn't get happy once she get groomed. I educated Mohammed that the dog will be easily infested by external parasites and that means the dog can be infected by tick bite fever. I then told him prevention is better then then cure and also it will be costly once the dog get sick. I then offered a sterilization regarding a pitbull and Mohammed told me he is interested but we must give him time as he wanna sort out the property to ensure the cars are moved to his new shop.

I issued a notice to comply stating

Zena was I observed to have a matted coat.

Zena must be groomed within 7 days. The grooming must be done by an experienced person to avoid unnecessary suffering.
