I observed the dog in question heavily pregnant and it has access to adequate wooden shelter. Portable water is provided for the dog and the living environment is clean and hygienic. I then contacted Xolani who is the owner of the dog regarding a sterilization and he told me he will call to make arrangements as the dog gives birth. The dog on property is roaming freely.

Proof is attached dog in question was euthanized due an injured.

There is no contravention of the animals protection act 71 of 1962 and there is no further action that can be taken in terms of the Act. I strongly believe the case can be closed.
