The dog in question was observed on a static chain that is 7 meters long having access to shelter and water. Sandile told me he doesn't wanna lose his dog as Nqe's dog passed away during the week as it was sick. He further stated that it is not fair for him cos it seems he doesn't have a choice as out of the three dogs in the video the only dog that is remaining is his dog. Thobile was present when i was having a conversation with Sandile Zulu the owner of the pitbull. Thobile then requested that I must give them a chance to hide the dog by moving it to another area. I made it clear that it is a criminal offense to conceal evidence as I can see the dog and they must load it on my vehicle.
