Two dogs were observed roaming freely on property and they appear to be in a good condition/good health. The living environment is clean and hygienic. The dogs have access to the house at all times and sufficient water is provided for the dogs. I questioned David if does he have any idea of his dogs killing the cat and he stated he has a cat past few weeks. The cat entered a neighbors house and got bitten. He had to put the kitten to sleep as he understood that some dogs don't get allong with cats.

On my inspection there is no contravention of the Animals Protection Act 71 of 1962 and there is no further actions that can be taken in terms of the Act. I strongly believe with these findings the case can be closed until further notice.
