There was no open wound observed and the 2nd dog on property appears to be in a good condition.

The dogs are kept separated at all times as they don't get along and according to Raffick by mistake on dog escaped from it section. That is where they attacked each other and Raffick was quick to separate them. The dogs have access to water and shelter. The dogs are not used for dog fighting and i tried to convince Raffick to surrender the dog but he refused and I offered a sterilization but he will think about it.

I issued a warning
To provide injured animal with adequate veterinary treatment with 48 hours.
Or surrender the dog named Pitty to Kloof and Highway SPCA.
