I further told her that the dogs must always roam freely on property at all times. She then told me that she want her dogs to sleep in the house and i further explained that keeping the dogs in the garage at all times will cause distress as they don't even have toys. She told me that I'm not allowed to take pictures.

She then moved the dogs to the backyard to roam freely while i was on the property.

I issued a notice to comply
