General Report Comments: Upon arrival I shouted and the maid came to the gate. She then told me she will go back to the house to call the owner.

She came back with Cedric. I shared a nature of complaint and he granted me access to the property. I then observed 1 dog roaming freely on property and we went to the veranda where I observed a 2nd dog kept on a static chain. The 2nd dog is the dog in question named Cash and the dog have access to adequate shelter. Both dogs appears to be in a good condition and clinically alert. The dogs have access to portable water.

I then questioned Cedric why the dog is kept on the static chain that is 2 meters while the property is very big. Cedric told me the dog is on heat and it jumps the fence to mate with the male dogs. While i was walking around the property I could see male dogs outside the property. I then told Cedric that he must sterilize the dog so he doesn't chain it at all. He then told me he is a breeder and he won't sterilize a dog he bought for R40 000

He then told me that the neighbors are jealous because he is the only indian with a big yard. I then told him that my job is examining the walfare of the animals not politics. He further claimed he knows who the complaint is. I told him it was an anonymous complaint and even if i knew I wasn't gonna disclose the name of the complaint. I then told him I'll issue a notice with a time frame to rectify the chaining of the dog and he tried to convince me that there is no need. I replied to Cedric that every education in terms of the Animals Protection Act must be in writing .

I issued a notice to comply
