General Report Comments: We saw approximately 45 dogs in total. Some of the adults did have cropped ears but they were born before 2022. Most of the people there had bought their dogs with cropped ears. We did notice that the breeders that had their puppies there ,all had long ears. There were also some older dogs with long ears. We were very happy to see that the puppies had long ears . Dogs were in adequate sized cages and were exercised frequently. The dogs that were in the cages seemed very calm. There was no cage aggression seen. The dogs were all in shaded areas and as the sun moved over they moved their dogs into the shade. All the dogs had water at all times and it was even announced every few minutes asking the owners to ensure that their dogs had water at all times and that they were being exercised. Stacking of the dogs went well, none of the dogs were too tired to stack. We also found that alot of the owners had left before 4 and the last few owners left soon after 4. When we got there we told the organisers that the show is not to go on longer than 4. We commended the owners for taking good care of their dogs and ensuring that all their needs were met. We also commended owners who had dogs with long ears . The organisers did announce that no dogs after 2022 are to have ears cropped anymore as it is now illegal.
