3 dogs approached the gate and the dog that had a swollen eye has healed there is no swelling observed. I then observed a pitbull female dog that is slightly underweight but it looks like she has puppies. The pitbull was observed to have an injury at the back of the right ear. It looks like an old injury that wasn't given attention. The 3rd dog appears to be in a good condition. The living environment appears to be clean and hygienic. All the dogs observed are freely roaming on property.

I issued a warning for owner, caregiver or occupant to
-contact SPCA inspector Lindokuhle on 83 270 1371 within 24 hours to discuss the concerns.
-To provide injured animal/s with adequate veterinarian treatment within 48 hours and provide the SPCA with a veterinarian report within a given time frame
