Two dogs were observed and they appear to be in a good condition and clinically alert. The dogs have access to adequate kennel and water is provided. The living environment is clean and hygienic.

Riaan took me to the back where the dog that has puppies. The dog appears to be in a good condition and clinically alert. I went to check the puppies in the kennel and 4x puppies were observed. The puppies appeared to be in good health and the living environment is clean. Portable water is also provided in this section. Riaan was busy shouting so the neighbor can hear him busy saying they can't afford to have animals.

Riaan took me back into the house where he showed me adequate food for the dogs and treats he bought for his dogs. Riaan doesn't wanna sterilize his dogs at all and he showed me Vaccination cards.

There is no contravention of the animals protection act 71 of 1962 and there is no further action that can be taken regarding the act. I strongly believe the case can be closed until further notice.
