He added the veterinarian told him the dog is fine and that when i told Royden that i wanna know that veterinarian. He bailed out and stated he forgot the veterinarian.

Roydens wife tried to get involved stating people should mind their business her dog is fine and they wont surrender the dog. I made it clear that they have 2 choices. To sign the dog now or seek veterinarian treatment. Royden told me they dont have money and i explained to him the dog didnt lose weight overnight

I issued a warning
