Rocky has access to adequete wooden kennel and portable water. The living environment is clean and hygienic. Anamalay explained that the dog is quick to exit the gate once it is roaming freely. They then told me how they plan to separate the property so the dog can be kept in a backyard. Looking at the dog i could see it will break a runner and they dont wanna surrender the dog.

I issued a warning  
Rocky was observed on a static chain that is short and he cannot express animal natural behavior.  
Provide a longer chain that is 7 to 10 meters long within 7 days.
