There was no chicken observed, i then questioned Evon regarding chickens and the chickens were sold on a previous day. I left the property i contacted the complaint and she stated that she heard the chickens have been sold. They were loaded in a bakkie for transportation.

I strongly believe the case can be closed. There is no contravention of the animals protection act 71 of 1962 and there is no further action that can be taken regarding the act. Case closed until further notice and all the animals on this property are sterilized.
