General Report Comments: Owner only gets home after 5H30pm

Upon arrival i hooted and shouted. Nomusa opened the gate and granted me access to enter the property. Two dogs were roaming freely during my inspection and her husband was present . We then walked to the backyard where other 3 dogs are kept.

These three dogs were kept on a static chain that was 6 to 7 meters. The dogs have access to portable water and shelter. The living environment is clean sand hygienic. All the dogs on the property appears to be in a good condition. I then questioned why the 3 dogs are kept on a static chain and according to the owner. She was threatened by the neighbor that he will poison her dogs and she ensure the dogs are roaming freely at night.

2024 around June she was hijacked while at the gate when she didn't have any animals on her property. She had break in monthly last year when she didn't have dogs, the family was gun pointed and robbed when they didn't have dogs.

Nomusa was in tears when she shared the story and further stated the complaint is her neighbor. On a previous week metro police was on her property and they told her that The complaint is the neighbor. I stated that i don't know who is the complaint. Nomusa further stated that her dog was poisoned last year and she took the animals to be put to sleep at northdene veterinary clinic. I tried to convince her to surrender her dogs however she wasn't interested. According to Nomusa the dogs never attacked one.

There is no contravention of rhe animals protection act 71 of 1962 and there is no further action that can be taken. I strongly believe the case can be closed
