While i was walking out of the property. Cindy pointed a lady accross the road she claimed was the complaint. The old lady was looking at us through the trees.

I strongly believe the case can be closed. There is no contravention of the animals protection act 71 of 1962 and there is no further actions that can be taken. All the dogs on this property are sterilized which is a sign that there is no breeding taking place at this address.
