General Report Comments: I received a complaint from management that the dog is roaming outside

I visited the address and the gate is locked. I hooted no response and i didn't see any dog on the road.

I then forwarded the case to Metro Police and they requested an email based on my inspection

Email:

Good Day Madam

I'm Inspector Lindokuhle from Kloof And Highway SPCA. I would like to report a case regarding 5 Jung Crescent in New Germany.

On the 08/05/2025 I responded to a complaint that the dog at 5 jung Crescent is always on the road and it underweight. On my findings the dog has a litter of puppies that it is feeding. The dog in question was at the property during the inspection, however in terms of the welfare the only concern is the dog is slightly underweight due to feeding the puppies.

On the 21/05/2025 I responded to the 2nd complaint that the dog is being hit by the owner and is always on the road. On my findings the dog was at the property and they denied ever hitting the dog. I offered a sterilization but they don't wanna sterilize the dog and the sterilization was for free. I explained the benefits of a sterilization however they are not interested.

On that inspection i issued a warning stating

-To keep the Animal/s inside your premises at all times

-It has been brought to attention that you were seen beating the dog. If we should receive any evidence supporting these allegations further actions may be taken.

We kept on receiving numerous complaints regarding the dog in question that it is roaming on the road. I made it clear that to every complaint that it falls under the infringement of the city bylaws that is enforced by Metro Police.

I then visited the 5 Jung Crescent on 22/05/2025 to sponsor the people who recide at the address with dog food (Pellets for puppy food) so the dog will gain weight quickly as we received another complaint that the dog is roaming around. On my findings the dog was at the property.

We keep on receiving complaints that the dog is roaming freely .

I'm referring the complaint to metro police to visit the address to investigate as Metro Police Protects residents rights within a municipal district and focuses on welfare of the community where the animals are kept.

-Dogs getting out of their premises.
