I observed 2 adult dogs and 7 puppies. The dogs appears to be in good health and clinically alert. The dogs has access to shelter and water. Zama stated showed me the part of the fence that she has fixed cos the male dog always find a way to get out and the puppies will follow him. Zama is no longer interested in keeping the male dog as it doesnt wanna listen. I educated Zama about a sterilization and her reply was she doesnt wanna keep the male dog anymore. The puppies are still lactating and once they old enough she will sign the dog over to the SPCA. Other puppies will be taken to her home in Harding and she will be keeping 2 of the puppies that she will raise on her own. I assisted Officer Njilo to load the dog in his van.

I strongly believe the case can be closed. There is no contravention of the animals protection act 71 of 1962 and there is no further action that can be taken.
