- * Clean and remove all the faeces that was found on the floor of the stoep in front of the house.
- * Clean all the dog beds and blankets that were found on the floor of the stoep.
- * Clean the floor of the lounge and disinfect the floors after cleaning.
- * Clean and remove all the cat faeces, old cat food, and any dust or dirt that was found on the floor of the bedroom where the cats are kept in.
- * Disinfect the bedroom floor.
- * Clean the litter boxes thoroughly and disinfect the boxes afterwards.
- * Provide fresh litter / woodshavings in all the litter boxes → ensure the litter / woodshavings are replaced daily.
- * Clean the water and food bowls thoroughly and ensure there is no dirt accumulation on the surfaces of the bowls. → ensure bowls are cleaned daily.
- * Provide fresh potable water at all times.
- * Clean and remove all the sponge pieces, pieces of paper and plastic, and old dog food that was found on the floor of the stoep at the back of the house.
- * Clean all the dog beds and blankets that were found on the stoep.

 - * clean and remove all the cat faeces and old cat food that was found on the floor of the large cage the 3 x cats are kept in.
 - * clean the water and food bowls that were found in the large cage the 3 x cats are kept in.
 - * Provide fresh potable water at all times.
 - * Clean the plastic pond found in the large cage the 2 x ducks are kept in. → ensure there is no algae accumulation on the surfaces of the pond or water.
 - * clean the water and food containers in the large cage the 2 x ducks are kept in.
 - * Provide fresh potable water at all times.
 - * remove all hazardous materials; such as, razor wire, wall spikes, loose fencing that was found in the backyard.
- You are hereby given 7 days to adhere to the instructions from page 1 (NTC No. 0809) and page 2 (NTC 0810). Failure to do so may result in further action being taken against you.
