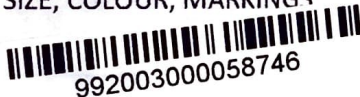

ADOPTION CONTRACT

This animal has been given to you in the firm and confident belief that it will receive a good home with responsible and loving care.

Ownership of an animal yields much pleasure and satisfaction. It also has its obligations and responsibilities. The fact that the animal has been in our care usually indicates that someone has, in the past, failed to recognise these responsibilities.

I do hereby confirm and undertake that:

1. I am over eighteen (18) years of age.
2. I will not part with possession of the animal except to **return** it to the SPCA if for any reason I am unable to keep it. In the event that I fail to do so, I agree that I will be liable to pay to the SPCA all costs which they may incur in obtaining confirmation that the animal has been homed to a suitable person, with suitable premises. In the event that this is not the case, I also agree that I will be liable for all costs which the SPCA may incur, including all legal costs on an attorney and client scale, in recovering possession of the animal.
3. I will give the animal a fair chance to adjust to its new home.
4. I understand that donations are not refundable or transferable.
5. I will feed and house the animal to the Society's satisfaction.
6. I will **not chain or cage** the animal, and understand that if it is found chained or caged, it will be removed from my care immediately.
7. I can afford the services of a private veterinary practitioner.
8. I will ensure that vaccinations are kept up to date and in the case of injury or illness professional veterinary treatment will be provided.
9. I understand that in the case of illness (not injury) occurring within the first seven (7) days of adoption, I may bring the animal to the Society to be attended to by its veterinarian (at the discretion of the Society) at no charge to myself.
10. I will ensure that the animal is sterilised as stipulated by the Society.
11. I undertake to ensure that the animal has identification at all times, either in the form of a microchip or a collar and tag - only **elastidised or quick release collars** may be used for cats.
12. My property is adequately enclosed and at no time shall I knowingly allow my dog to roam the streets.
13. I will notify the Society within forty-eight (48) hours should the animal die or go missing.
14. I know and understand the "By-Laws pertaining to animals" of the Municipality in which I reside.
15. I will permit an authorised officer of the Society to visit my premises from time to time, to be assured that the animal is being treated in accordance with this Policy, and I will allow the Society to repossess the animal, if in the Society's opinion, the terms of this policy are not being reasonably adhered to.
16. I will not use or allow the animal to be used as a watchdog on any industrial or commercial premises.
17. I will notify the Society of any change of address in writing by registered post within seven (7) days.

Daar is ook verantwoordelikhede en verpligtinge wat nagekom moet word. Die feit dat hierdie dier in ons sorg was, dui gewoonlik daarop dat iemand hulle plig versuim het.

Ek onderneem en bevestig dat:

1. Ek ouer as agtien (18) jaar is.
2. Indien ek vir enige rede nie langer die dier kan versorg nie, onderneem ek om dit alleenlik aan die DBV **terug te besorg**. As ek om enige rede nie daartoe in staat is om die dier te hou nie sal ek nie besit van die dier afstaan nie tensy ek dit aan die DBV teruggee. Ingeval ek nie so optree nie, aanvaar ek aanspreeklikheid om alle onkoste aan die DBV te betaal wat hulle mag aangaan in die verkryging van bevestiging dat die dier by 'n geskikte persoon met aanvaarbare huis en erf gehuisves is. Ingeval dit nie die geval is nie, insluitende die regsonkoste volgens 'n prokureur en klient skaal, in die terug verkryging van die dier.
3. Ek sal die dier 'n redelike kans gee om aan sy nuwe tuiste gewoon te raak.
4. Ek begryp dat donasies nie oordraagbaar is of terugbetaal word nie.
5. Ek onderneem om die dier te versorg en te huisves na die Vereniging se tevredenheid.
6. Ek sal nie die dier **vasketting of gehok hou nie**, en aanvaar dat indien die dier wel in my besit vasgeketting of gehok gevind word, die Vereniging dit dadelik sal verwyder.
