Comments:	MET WITH THE COMPLAINANT AND THE GROUNDS KEEPER OF THE GOLF COURSE, THEY HAVE ADVISED THAT THE DOGS ONLY COME IN THE EVENINGS, SETTING A TRAP TO BE LEFT THERE IN THE EVENINGS WILL RESULT IN THE TRAP BEING STOLEN. Veterinary assistance: Arranging with a local veterinarian to safely dart the dogs where trapping is not possible. WE DO NOT HAVE A VET THAT IS ABLE TO DO THIS WITHOUT KNOWING THE EXACT TIMES AND LOCATION OF THESE DOGS Feeding station: Establishing a feeding station to attract the dogs and, over time, gradually moving it to a suitable area where they can be enclosed. THIS WAS DISCUSSED WITH THE COMPLAINANT AND THE FEEDING AREA WILL BE TOO CLOSE TO THE AREA THE CATS ARE ACCUSTOMED TO COMING AND MAY LEAD TO FURTHER CASUALTIES Community involvement: Encouraging residents to assist by reporting sightings, helping to monitor feeding stations, and supporting the trapping process. THE COMMUNITY HAVE AGREED TO SEE IF THERE ARE CAMERAS IN THE AREA THAT CAN SEE WHERE THE DOGS COME FROM AND AROUND WHAT TIMES. IT HAS ALSO BEEN SUGGESTED TO CHANGE THE FEEDING TIMES FOR THE FERALS TO THE MORNINGS TO ENSURE THEY ARE NOT IN THE SAME AREA WHEN THE DOGS COME. IT HAS TO BE NOTED THAT THE SPCA HAVE IN THE PAST REMOVED A CERVAL FROM THE AREA, THAT HAD TO BE HUMANELY EUTHENAZED DO TO ITS CONITION, THIS WAS DONE THROUGH DOCTOR NEWBY, THE POSSIBILITY OF THIS TYPE OF PREDATOR PREY COULD ALSO BE THE CAUSE OF THE DEATHS OF THE CATS. WE WILL CONTINUE TO STAY IN CONTACT WITH THE COMPLAINANT AND FOLLOW ALL LEADS ON THE DOGS AS THE SIGHTINGS ARE REPORTED.
