General Report Comments: Chicken numbers: The number of chickens on the property has not yet been reduced, as previously advised.

Fish enclosure: Plants have been added to the swimming pool to provide environmental enrichment for the fish, and the pump was running at the time of inspection, indicating improved water circulation and maintenance.

Ducks: The ducks' shelter contained clean wood shavings, showing improvement in hygiene. The owner had attempted to plant grass for them; however, the ducks uprooted the newly planted grass. It was suggested that they use a bale of hay or straw as a suitable and manageable alternative for ground cover and enrichment. Food and clean water were available.

Rabbits: The rabbits had access to grass and pellets at the time of inspection. Their sleeping area had been cleaned and improved, providing adequate comfort and shelter.

Conclusion:

Overall, notable progress has been made in improving conditions for the fish, ducks, and rabbits. However, the chicken population remains excessive,
