General Report Comments: Observations:
Upon inspection of the property, multiple dogs were observed in poor physical condition and unsuitable living circumstances.

Total Dogs Observed: 11

6 Greyhounds:

Brindle male

Tan male

Black female

Tan female

Brindle male- FAIR CONDITION

Tan female – old injuries noted on back right leg- FAIR CONDITION

1 Crossbreed male – brown, cropped ears, found chained

3 Crossbreeds – 2 females and 1 male

1 Staffie-cross type female – black, found chained

Condition of Animals:

All visible dogs appear emaciated, with prominent ribs, and hips

External parasites (ticks and fleas) were present in large numbers on all dogs.

Old injuries were noted on the back right leg of one tan female Greyhound.

All collars were removed from the Greyhounds, as they were too tight, the collars were removed from the property.

Environmental Conditions:

Excessive faecal buildup present throughout the area.

No food or food bowls available on the property. However there were buckets present that the owner claims the water is placed in.

No water was provided or accessible to the dogs at the time of inspection.

The enclosure space is inadequate for the number of dogs housed.

Grass and vegetation are excessively overgrown, contributing to poor hygiene and pest infestation.

Conclusion:

The conditions observed constitute a serious welfare concern. The dogs are being kept in an unsanitary and neglected environment, without access to basic necessities such as food, water, or adequate space. The presence of untreated injuries, external parasites, and emaciation indicates prolonged neglect
