General Report Comments: In the back yard a large confined "cage" contained two Pitbulls. The area was inaccessible as it was closed off with rubble, plastic pallets, and metal fencing. The inside of the "cage" was filthy with excess dog faeces and rubble. No water was present, as the three dirty buckets inside were empty. A makeshift kennel was present in the back of the "cage". Upon closer inspection the male Pitbull was chained within the "cage" on a short thick chain. Apparently the dog was being chained because the female is on heat. The male Pitbull was also thin, with his rib and hip bones protruding. The female Pitbull was in fair body condition but had patches of missing hair on her back on the base of the tail. I was informed the dogs are fed a diet of pap and sawdust.

The owners both came with many excuses as to why the dogs are chained and caged in filthy conditions, the main excuse being that the yard is not secure to have the dogs free roaming as the walls are not present or are too short. After explaining in explicit detail to the owners the contraventions of the Animals Protection Act, the owners requested one chance to rectify all the concerns. I advised the owners they can have one chance to rectify all the concerns, otherwise legal action will be taken against them.
