General Report Comments: Incident Overview

The NSPCA Farm Unit manager alerted me to an overturned truck carrying live chickens that had overturned on a roadway in Delmas. Upon receiving the call, my colleague Paulos and I proceeded to the given location. While en route, I contacted three sister SPCA Societies to be on standby in case additional assistance was required.

Upon arrival, the truck was found on its side, with multiple vehicles and personnel on-site. Forklifts were being used to reposition the poultry trolleys that had been displaced. The total estimated number of chickens involved was over 11,000.

Response Actions

Animal Recovery & Welfare Assessment:

Trolleys were systematically righted, and crates were extracted.
Chickens were assessed for injuries and mortalities.
Severely injured birds were humanely euthanized to prevent further suffering.
Surviving chickens were placed back into secure containment for transportation.
Coordination & Support:

Multiple stakeholders collaborated on-site to manage the situation effectively.
A replacement transport vehicle was arranged for the surviving birds.
Brakpan SPCA provided direct assistance without delay.
Sister Societies remained on standby throughout the operation.

Conclusion

The response to this incident was executed efficiently despite the scale of the situation. The surviving chickens were successfully transported, and deceased animals were appropriately handled.
