General Report Comments: During the start of inspection, it was observed that a truck filled with cattle was leaving the feedlot, carrying the scheduled Tuesday load of 16 cattle to the abattoir. The pens have dried considerably since the previous visit, indicating progress in managing the wet conditions. Since the first inspection, the majority of the cattle have been successfully moved to the new pens located on the property opposite the feedlot - 40 cows and 150 young bulls have been relocated to the opposite property. The young cattle have been placed in the newly constructed pens, while the cows and bulls are being allowed to free-roam on different sections of the property. The cows are roaming half of the property, while the bulls are free to roam the other half. The remaining cattle were being weighed at the time of inspection.

The construction of new infrastructure has continued. Earlier in the morning, cement was laid in the new pens, which had been filmed by the feedlot owners and sent prior to the inspection. It was noted that temporary feed and water troughs have been installed for the animals, as the permanent troughs have yet to be purchased or installed. Fly traps for the new area have already been ordered. These traps are expected to be installed by the end of the week. Half of the pigs have already been moved into two pens in the new piggery, which will provide better housing conditions and improved waste management systems.

The feedlot is expecting a delivery of stoney sand next week, which will be used to reconstruct the flooring of the old pens. This is part of the ongoing efforts to improve the infrastructure and address issues such as flooding and mud accumulation. The reconstruction of the old pens will provide more stable conditions for the remaining livestock and help further reduce the impact of the wet weather conditions on the feedlot.
