FOLLOWING CONCERNS WERE NOTED:

- 1) NO WATER WAS PRESENT OR AVAILABLE FOR THE  
THREE ADULT DOGS AND SIX PUPPIES
- a) THIS WAS RECTIFIED IMMEDIATELY, FRESH, CLEAN  
POTABLE WATER HAS TO BE AVAILABLE ON A  
CONTINUOUS BASIS
- 2) THE GATE <sup>ON</sup> THE RIGHT HAND SIDE OF THE FRONT  
DOOR, THAT IS BEING USED AS A TEMPORARILY HOUSING
