- Please be advised that all unsterilized bitches and queens – and any males deemed necessary – shall not be released from the Brakpan SPCA without first being sterilised. This will be at additional cost to the treatment.
- Furthermore, we advise that it is YOUR responsibility to contact the Brakpan SPCA concerning the progress and treatment of your animal. Should you fail to contact the Brakpan SPCA within 7 days of admitting your sick or injured animal, it shall be considered abandoned and we will deal with the animal as we deem fit.
- ALL MONIES will be paid in full to the Brakpan SPCA before your animal is released back into your care. Failure to pay all outstanding monies within 7 days of the sick / injured animal's last date of treatment will result in the animal being considered abandoned and the Brakpan SPCA shall deal with the animal as it deems fit. No further correspondence will be entered into.
- Please note any correspondence will be between you and the Brakpan SPCA ONLY and at no time between you and the veterinary clinic.
- Once the animal has been admitted into our care, it shall not be released until treatment is complete.

1. If the adopted animal is not sterilised on the due date mentioned above, the SPCA reserves the right to enter the above property and confiscate the animal. No money will be refunded.
2. The adopted animal cannot be passed on to a new owner. Please see clause 2 of the adoption contract.
3. The SPCA and its Veterinarian will not be held liable for any loss, theft, sickness, injury or death of any animal admitted for sterilisation. All reasonable precaution will be taken whilst the animal is in the SPCA's care. The SPCA does not have overnight staff to monitor animals after surgery.
4. It is understood that the signature on this document is that of the legal owner of the animal. Should it not be that of the legal owner, you are advised that you will have no legal recourse to take any action against the SPCA.
5. Failure to collect and pay the outstanding monies within (7) days of the animal's sterilization date shall result in the SPCA considering the animal to have been abandoned and they shall do with the animal as they deem fit. No further correspondence shall be entered into.
6. I understand that any procedure involving anesthetic does carry certain risks for the animal involved even though all reasonable precaution will be taken whilst the animal is in the care of the SPCA. I further understand that the SPCA Clinic is not equipped to deal with emergencies to the same extent as most private veterinary practices.
7. **Should your dog/cat be found to be pregnant/on heat/pyometra during sterilisation, a MINIMUM of R300-00 surcharge will apply.**
8. It is not a requirement that the BRAKPAN SPCA signs this contract for it to be effective and it will come into effect on the owner's/adopters signature.

ADOPTION CONTRACT

This animal has been given to you in the firm and confident belief that it will receive a good home with responsible and loving care. Ownership of an animal yields much pleasure and satisfaction. It also has its obligations and responsibilities. The fact that the animal has been in our care usually indicates that someone has, in the past, failed to recognise these responsibilities.

I do hereby confirm and undertake that:

- (1) I am over eighteen (18) years of age.
- (2) I will not part with possession of the animal except to return it to the SPCA for any reason I am unable to keep it. In the event that I fail to do so, I agree that I will be liable to pay to the SPCA all costs which they may incur in obtaining confirmation that the animal has been home to a suitable person, with suitable premises. In the event that this is not the case, I also agree that I will be liable for all costs which the SPCA may incur, including all legal costs on an attorney and client scale, in recovering possession of the animal.
- (3) I will give the animal a fair chance to adjust to its new home.
- (4) I understand donations are not refundable or transferable.
- (5) I will feed and house the animal to the Society's satisfaction.
- (6) I will not chain or cage the animal, and understand that if it is found chained or caged it will be removed from my care immediately.
- (7) I can afford the services of a private veterinary practitioner.
- (8) I will ensure that vaccinations are kept up to date and in the case of injury or illness, professional veterinary treatment will be provided.
- (9) The pet I am adopting has received an initial vaccination and has been dewormed by the Brakpan SPCA. I am satisfied with the current health status of the animal I am adopting. I understand that should the animal fall ill after being adopted, I will not hold the SPCA liable for any vet bills that may be incurred. If problems arise with the sterilisation wound of the animal, I may bring the animal to the Society to be attended to by its veterinarian at no charge to myself.
- (10) I will ensure that the animal is sterilised as stipulated by the Society.
- (11) I will identify my dog with a collar and identification tag - only elasticised collars must be used on cats.
- (12) My property is adequately enclosed and at no time shall I knowingly allow my dog to roam the streets.
- (13) I will notify the Society within forty-eight (48) hours should the animal die or go missing.
- (14) I know and understand the "By-Laws Pertaining to Dogs" of the Municipality in which I reside.
- (15) I will permit an authorised officer of the Society to visit my premises from time to time to be assured that the animal is being treated in accordance with this contract, and I will allow the Society to repossess the animal if in the Society's opinion, the terms of this contract are not being reasonably adhered to.
- (16) I will not use or allow the animal to be used as a watchdog on any industrial or commercial premises.
- (17) I will notify the Society of any change of address or telephone number in writing by registered post within seven (7) days.
- (18) I undertake to take all reasonable steps to maintain the animal in a good and healthy state and to ensure the animal has adequate food and water at all times. Should the animal be found at any time in a condition which the Society, or its representative, is of the view is not healthy, then the Society may forthwith repossess the animal.
- (19) I undertake to refrain from surgically altering any part of the animal's body other than for medical reasons. I understand that cropping ears and docking tails for cosmetic reasons is against the Law.
- (20) I agree that if I breach any of the above terms, the SPCA will have the right to enter upon my property and take repossession of the animal. I will then forfeit all rights and claims to the animal, and will have no right of action or recovery against the SPCA for any reason whatsoever.

- (1) Ek ouer as agtien (18) jaar is.
- (2) Indien ek vir enige rede nie langer die diër kan versorg nie, onderneem ek om dit alleenlik aan die DBV terug te versorg. As ek om enige rede nie daartoe in staat is om die diër te hou nie sal ek nie besit van die diër afstaan nie tensy ek dit aan die DBV teruggee. - (6) Ek sal nie die diër vaskeet of geshok hou nie, en aanvaar dat indien die diër wel in my besit vasgekeet of geshok gevind word, die Vereniging dit dadelik sal vander.
