Kindly forward our response to NSPCA

We investigated the matter and here are our findings:

We visited the property at 7 A Boet Street and found a construction company busy renovating the house. We obtained the contact details of the property owner, Mr. Nick Viljoen, at 0832615104. I contacted him to gather information about the tenant who allegedly abandoned two cats. Mr. Viljoen informed me that he assisted the previous resident, AJ van Tonder, in moving on Friday, July 5, 2024. He was present when the owner of the cats tried to catch them, but the cats jumped over the fence and could not be caught. He also mentioned that, to his knowledge, AJ took his two dogs to the SPCA, which I confirmed to be true.

Our staff reported that AJ was very emotional when he handed over the dogs, explaining that he was evicted because he couldn't pay rent and his father went to jail. I contacted AJ and asked about the cats and the allegations of abandonment. He reiterated what Mr. Viljoen said—that he couldn't catch the cats and had returned four times over the weekend without success.

I informed the complainant that AJ was still looking for the cats and mentioned that I will have to tell him that the cats are with her. She told me that she lost one cat, the male cat had escaped from her property. I asked her to contact AJ to explain the situation and seek his assistance in catching the cat. I was very concerned because the distance between her house and where the cats used to live was significant. She contacted AJ, who gave her permission to rehome the cats since she is the founder of Furever Cats NPC.

In the meantime, they managed to catch the male cat, and she rehomed him to a trusted individual, known to myself as a big animal lover. Mr. Groenewald apologized for getting involved and removing the cats without contacting us to handle the situation. We are grateful that the former owner did not press charges for theft and that the male cat was found and rehomed to a wonderful home.

I, (the abovementioned), hereby request that my animal(s) be kept at the Garden Route SPCA for safekeeping as I am presently not able to take care of it/them.

1. I understand that this is a short-term arrangement meant for emergency situations only. The SPCA is unable to keep the animal/s in safekeeping for longer than 7 days.

2. I confirm that I will fetch my animal/s on: 15/07/2024

3. **Safekeeping Fee:** I agree to pay a **deposit of R200 per animal** upon admission to the SPCA. Thereafter a fee of **R50 per animal per day** will apply. This is to cover the cost of feeding and caring for my animal/s. This excludes any possible medical treatment which may be needed, for which I will be liable. I agree to pay the full amount outstanding on collection of my animal.

4. **Penalty fee:** If I do not fetch my animal on or before the collection date provide in clause 2 above or make suitable arrangements in advance and accepted by the GRSPCA, I hereby agree to pay an amount of **R80 per day** for the extended safe keeping of my animal/s.

5. **Surrender:** I acknowledge and agree that my animal(s) will become the property of the Garden Route SPCA should I not fetch it / them within 7 days of the collection date provided in clause 2 above or arrangement has been reached as per clause 4.

6. I agree that the Garden Route SPCA is exonerated from any liability / legal action arising from whatever cause, whilst my animal is in their safekeeping.
